

Public offer to conclude a donation agreement

1. The meaning of this public offer

1.1 This public offer («Offer») is a proposal of the Foundation of Tatarstan of Academy of Sciences («Fund»), the details of which are specified in clause 5 of the Offer, to conclude a donation agreement with any person («Donor») who responds to the Offer («Agreement») For the statutory purposes of the Fund, on the conditions provided below.

1.2 The offer is a public offer in accordance with clause 2 of Art. 437 of the Civil Code of the Russian Federation.

1.3 The offer comes into force on the day following the day of posting on the Fund's website on the Internet at: <http://academyofsciences.fund>.

1.4 The Offer may be amended and supplemented, which come into force from the day following the day of posting on the Fund's Website.

1.5 The offer is valid indefinitely. The Fund has the right to cancel the Offer at any time without giving reasons.

1.6 The invalidity of one or several conditions of the Offer does not entail the invalidity of all the conditions of the Offer.

1.7 The Place of the Offer is considered to be the city of Kazan, Republic of Tatarstan, Russian Federation.

2. Essential terms of the Agreement

2.1 Donation amount: the donation amount is determined by the Donor.

2.2 Purpose of the donation: donation for the conduct of statutory activities.

3. The procedure for concluding an Agreement

3.1 The Agreement is concluded by acceptance of the Offer by the Donor.

3.2 The Offer can be accepted by the Donor in any of the following ways:

3.2.1 by transferring funds by the Donor in favor of the Fund by a payment order according to the details specified in clause 5 of the Offer, indicating «Donation for the conduct of statutory activities», in the line: «purpose of payment», as well as using

payment terminals, plastic cards, electronic payment systems and other means and systems that allow the Donor to transfer funds to the Fund;

3.2.2 by sending a short message (SMS) by the Donor with the following words:

- [amount of payment in rubles] to a short number used to collect donations for the statutory purposes of the Fund;

3.2.3 by placing cash (banknotes or coins) in boxes (boxes) for collecting donations, established by the Foundation or by third parties on behalf and in the interests of the Foundation in public and other places.

3.3 The performance by the Donor of any of the actions provided for in clause 3.2 of the Offer is considered an acceptance of the Offer in accordance with clause 3 of Article 438 of the Civil Code of the Russian Federation.

3.4 The date of acceptance of the Offer and, accordingly, the date of conclusion of the Agreement is the date of receipt of funds from the Donor to the current account of the Fund, and in the case provided for in clause 3.2.3 - the date of withdrawal by authorized representatives of the Fund of funds from the box (box) for collecting donations.

4. Other conditions

4.1 By performing the actions provided for by this Offer, the Donor confirms that he is familiar with the conditions and text of this Offer, the goals of the Fund, realizes the significance of his actions, has the full right to perform them and fully accepts the terms of this Offer.

4.2 This Offer is governed by and construed in accordance with the legislation of the Russian Federation.
